Gift Aid Declaration Notes

If your declaration covers donations you may make in the future:

1. Please notify the charity if you change your name or address whilst the declaration is in force.
2. You can cancel the declaration or standing order at any time by notifying the charity – it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
3. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that the charity reclaims on your declaration in the tax year (with the current basic rate of tax at 22%, this equates to 28p for each pound you give).
4. If, in the future, your circumstances change and you no longer pay tax referred to in point 3, you can cancel your declaration.
